- To provide a challenging and stimulating study environment that facilitates the developing and extending of their practice and subject specific skills.
- To develop an understanding of the differences between practice-led research and theoretical research.
- To equip students with the necessary transferable skills for lifelong learning, employability and flexibility in the context of changing labour markets.
- To provide students with the skills and knowledge required to maximise career and post graduate opportunities.
